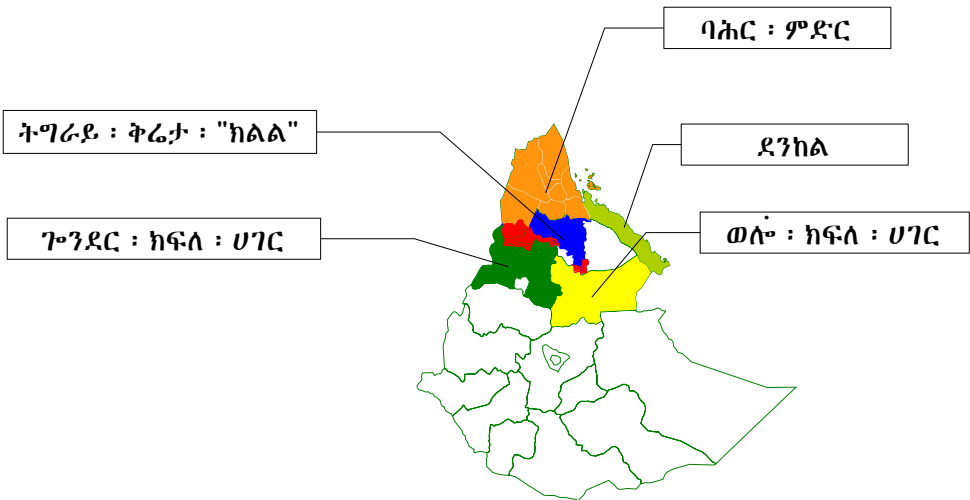

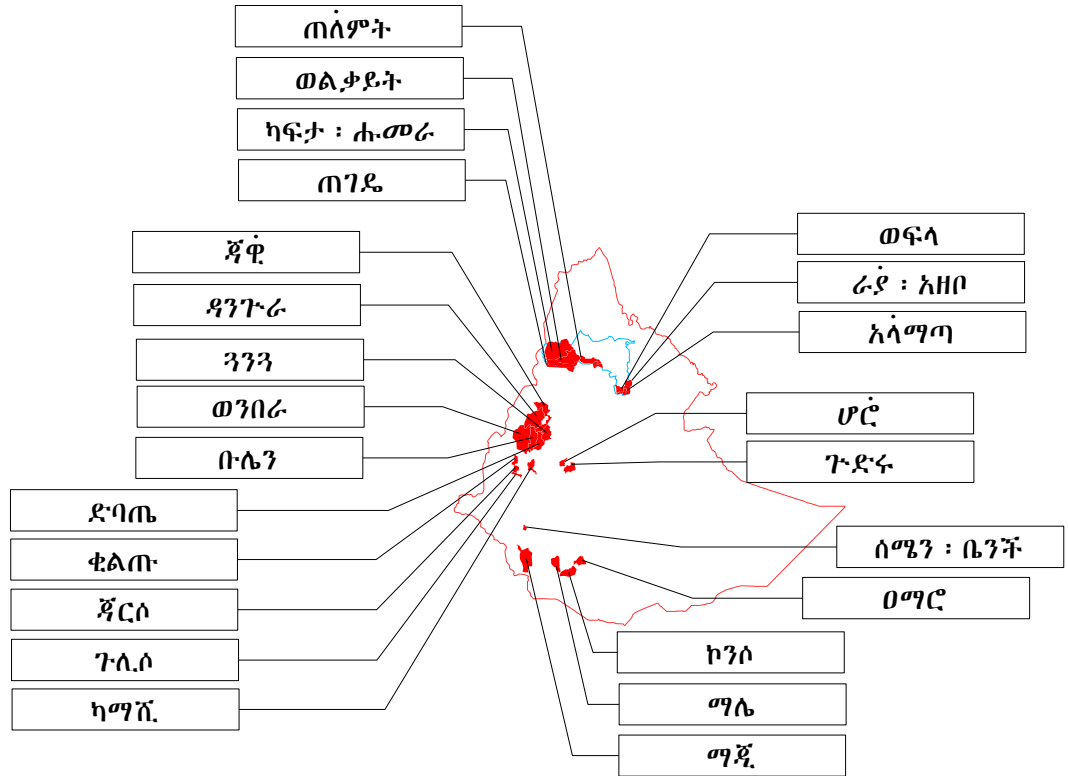

## PRESS RELEASE

(English translation of the Amharic original)

### A Failed Remnant Régime.

London, 6<sup>th</sup> January 2021.

A traitor to Ethiopia from its beginnings, the T.P.L.F. (Tgray People's Liberation Front) carried out on the night of 3<sup>rd</sup> of November 2020 particularly barbaric massacres of both civilians and members of the military stationed in the northern districts of the province of Gwender / ጎንደር, in the whole of the province of Tgray / ትግራይ, and in the northern districts of the province of Wello / ወሎ, in a dastardly act of complete desperation and disregard for the sanctity of life. In all, this criminal organisation has murdered many thousands of fellow citizens, destroyed considerable property, including infrastructure. By attacking military posts, it has exposed the country to external threats; furthermore, the T.P.L.F. has claimed full responsibility for these horrendous acts of treason.

There are no adequate expressions of sorrow and condemnation in the face of such evil and perfidious acts, other than to say that the organisation, T.P.L.F., should be dissolved and banned, and its leadership apprehended, and deferred before national law courts for crimes of national treason, crimes against humanity and war crimes.

However, as the foreign implanted apartheid system and undisclosed participants and accomplices are behind these treasonous acts and massacres, the whole issue should



rightly be examined by national judicial authorities within the framework of the transitional government. In this regard, the **Ethiopians' Citizen Democratic Union (E.C.D.U.)** will make public its position in due course.

The outlaw organisation T.P.L.F. has received no mandate from the patriotic and respected inhabitants of the province of Tgray; all the crimes committed against country are its own and those of imperialist forces that created it, financed it, organised it and remotely controlled it over the past fifty years. The inhabitants of the province of Tgray know they are innocent; the whole of the Ethiopian people know of the innocence of the inhabitants of Tgray, and the people of the World must also know of their innocence. As a testimony to their fidelity to their country, ignoring the repeated appeals of the T.P.L.F., the inhabitants of Tgray have shown their full support for the "law enforcement campaign" by scrupulously following the Ethiopian army's directives in all the areas of operations. Whenever necessary, the inhabitants have also fought alongside members of the Ethiopian army against the lawless force that had been oppressing them for so long.

**The Ethiopians' Citizen Democratic Union (E.C.D.U.)** expresses its deepest sense of grief over the killing of innocent Ethiopian civilians, and the sacrifice of the brave who confronted and vanquished the evil of fascism; it prays for the redemption of their souls. The **E.C.D.U.** sends its deepest condolences to the bereaved families and the whole Ethiopian people, and prays unto God to give them strength. The **E.C.D.U.** is confident that as soon as Ethiopia re-constitutes her democratic State, the victims and the bereaved shall receive compensations.

Until then, the **E.C.D.U.** addresses, with its best wishes, its patriotic appeal to:

- 1) the inhabitants of the province of Tgray, freed from 30 years of T.P.L.F. tyranny: *«our most sincere congratulations on seeing this day of liberation; it is now your responsibility to peacefully hand over to law enforcement officials those criminals still hiding in your midst and busy preparing for you a new cycle of sufferings»;*
- 2) the inhabitants of the districts unlawfully transferred to the "Tgray homeland" from the provinces of Gwender and Wello: *«to you too our most sincere congratulations on seeing this day of liberation; until the time the "homelands' apartheid system" is dismantled and Ethiopia has democratically implemented a new administrative structure, keep steadfastly what is of your right and for which you have already made great sacrifices»;*
- 3) to the entire Free People of Ethiopia: *«our most sincere congratulations in this day of victory ; however much we regret the fratricidal nature of the struggle, what is vanquished is the evil spirit of nihilism, imported from the Western*



*World, that had been setting the Ethiopian people against themselves; its defeat now signals a better tomorrow for Ethiopia, once again our congratulations. Until the time the apartheid system is once and for all banished from the entire land of Ethiopia, do not be fooled by those tricksters who, claiming to "uphold" the illegitimate "constitution", announce fake "elections" and other make-believe. Instead, rise up in unison to take back control over your country Ethiopia, while safeguarding and ensuring her national unity and territorial integrity, for the purpose of making your new Constitution and establishing your new democratic State of Right».*

### **1: Blood on the hands of imperialism.**

Ethiopia is paying the heaviest of prices as a result of the forcible imposition upon her by the United States of America and certain Western nations back in 1991, of the apartheid system that South Africa had just rejected, in the shape of the F.D.R.E. (Federal Democratic Republic of Ethiopia) régime; an act of perfidy that dwarfs "Pearl Harbour" in its infamy. This was also an act that betrayed vengeance against the country that has always been at the forefronts of the anti-colonialist, anti-imperialist and anti-apartheid struggle. The régime was further placed in the hands of none other than the treasonous T.P.L.F.

As a consequence, for the next 29 years, Ethiopia was to be subjected to unimaginable sabotage, repression, discrimination, corruption, and overall mismanagement where, every year, billions of dollars' worth of the country's hard earned foreign currency were syphoned off outside the country with total impunity; all of this under the leaden silence of the "mean"-stream media. The latter do not fail to propagate, though, the "double digit growth" rates that the Ethiopian economy has supposedly achieved, failing to add that this "double digit growth" refers to the nominal growth rate and not the real growth rate; the nominal growth rate is worse than wiped out by a galloping double digit rate of inflation, resulting now in a stunted economy.

The T.P.L.F. led régime tried to meticulously carry through all its assigned key tasks meant to lead to the ultimate liquidation of Ethiopia as a State; among others:

- 1) by agreeing to carry out an unlawful referendum for the secession of the province of Eritrea, thereby illicitly giving away to her enemies a significant part of her people, her territories of Bahr Mdr / ባሕር ፡ ምድር and Denkel / ደንክል, as well as her entire Red Sea shores;
- 2) by endangering the national unity and territorial integrity of Ethiopia by partitioning her population and territory along ethnic lines;



- 3) by addressing the Ethiopian people divisively as "peoples" on the basis of the foreign imposed "constitution", in an attempt to deprive Ethiopia of her sole, rightful and sovereign people, her citizenry;
- 4) by trying to undermine the citizen language Amharic in favour of English;
- 5) by trying to substitute the idea of ethnicity to that of citizenship, as well as fomenting inter-ethnic strife that have led to daily massacres, mass displacements and exiles;
- 6) by mercilessly persecuting, torturing and killing all those who opposed it;
- 7) by embezzling the country's resources and State revenues;
- 8) by other equally deplorable acts.

Nevertheless, the T.P.L.F. was unsuccessful; instead, it is now liquidated.

Three years prior to its own liquidation, in 2017, hard pressed by the popular unrest in the country and fearing for its own existence, the T.P.L.F. sought a way out to complete its unfinished business of destruction from its hideouts in the "Tgray homeland". In so doing, it relinquished its dictatorial powers to its remaining partners in the remnant F.D.R.E. régime; without however showing any remorse for its past wrong doings other than to say that it is itself «rotten». Then, as the Holy Scriptures tell us: «*The dog is turned to his own vomit again ...*» (2Pe. 2:22), the T.P.L.F. left Addis Abeba to return to its bunkers in the Tigray "homeland", from where, through its latest horrifying series of atrocities committed all around the country, it showed once more to the whole World its truly vitiated, treacherous, fascistic and nihilistic nature. It is practically certified that to commit its crimes, the T.P.L.F. has benefited from the complicity, even the participation or the logistic support of some of its partners in the highest positions of power in Addis Abeba, with whom it backs the ongoing policy of "yugoslavisation" of Ethiopia through "ethnic cleansing".

There is no doubt that the barbaric killings committed in the districts of Welqayt / ወልቃይት, Tēgedé / ጠገዴ, Tēlemt / ጠለምት, and Kafta Humera / ካፍታ ሐመራ, particularly around the town of May Kadra / ማይ ካድራ, by the T.P.L.F. militia, on the 3<sup>rd</sup> of November 2020 until they beat retreat, taking the lives of well over 1'500 civilians, are all the result of a fascistic thought process bent on avenging the defeat of fascism in 1941. It is also a massacre similar to the one committed in Yugoslavia's Srebrenica enclave, with the purpose of likewise triggering the process of disintegration of Ethiopia.

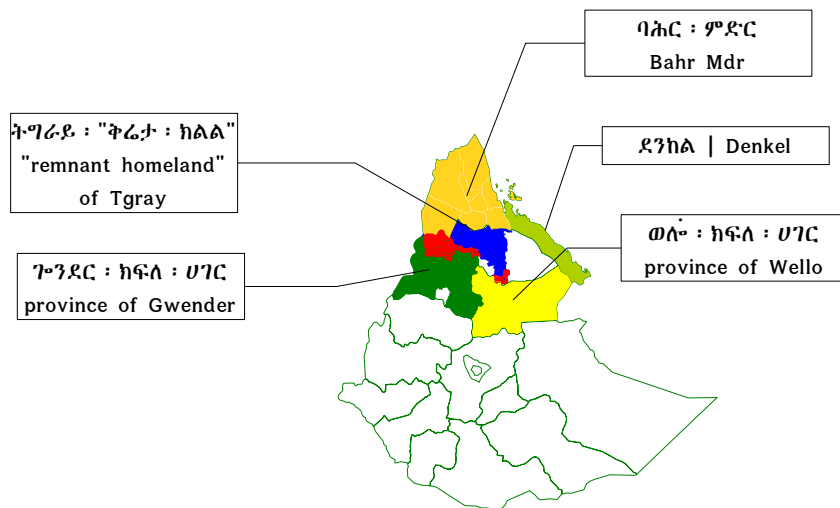
The reasons why the districts of Welqayt, Tēgedé, Tēlemt, and Kafta Humera [refer to map 1], were unlawfully transferred from the jurisdiction of the province of Gwender to



that of the Tgray "homeland", back in 1991, were:

- firstly, to take revenge on their inhabitants, whom during the invasion of fascist Italy (1935-1941), had, under the leadership of such resistance leaders as Bitweded Adane Mekwen-n / ቤት-ወደድ : አዳነ : መከ-ንን, accomplished extraordinarily heroic feats of arms that earned their region the nickname of "graveyard of fascists";
- secondly, to provide the Tgray "homeland", which imperialism has earmarked for "independence", a corridor to the Sudan;
- thirdly, to make the "republic-to-be" Tgray "homeland", in possession of large tracts of fertile agricultural land, with the addition of the districts of Rayya (ራያ) and Allamata (አላማጣ), also unlawfully transferred from the jurisdiction of Wello (ወሎ) province in 1991, thereby giving Tgray more than food self-sufficiency, its "lebensraum".

The mid-February 2013 massacres that resulted in thousands of innocent civilians being killed [refer to map 2], for the purpose of "cleansing" from "non-native" citizens or Amhara:

- the "Oromo / አሮሞ homeland" (in the Wellegga / ወሊጋ districts of Gouliso / ጉሊሶ, Qiltou / ቁልጡ, Djarso / ጃርሶ, Horro / ሆሮ, Gwdrou / ጉድሩ ...),
- the "Beni Shangoul Goumz / በኒ : ሻንጉል : ጉምዝ homeland" (in Metekkel / መተከል, Mandoura / ማንዱራ, Boulén / ቡሌን, Dbaté / ድባጤ, Kamashi / ካማሺ, ... districts),
- the "Deboub / ደቡብ homeland" (in Semén Béntch / ሰሜን : ቤንች, Madji / ማጂ, Konso / ኮንሶ, Amaro / ፀማሮ, Malé / ማሌ, ... districts),

were being routinely acknowledged by the usual press statement of the E.P.R.D.F. - Prosperity Party led FDRE remnant régime, until the time, according to the statement of the Foreign Ministry spokesman, the «*red line was finally overstepped*» when army divisions stationed in "Tgray homeland" were attacked by T.P.L.F. forces; only then was the régime forced to launch rather belatedly the "law enforcement campaign". Numerous evidence have confirmed that until the 3<sup>rd</sup> of November 2020 attacks on the army, the remnant F.D.R.E. régime had been "blaming" on T.P.L.F. operatives the so-called "ethnic cleansing" massacres – which in fact are anti-citizen (anti-Amhara) massacres – committed elsewhere in the country, but failed to take any action, as the régime was tacitly agreeing to the end result of these anti-citizen attacks: the consolidation of "ethnically cleansed republic-to-be-homelands". As we were about to complete this press release, we have learned with great sadness the massacre of a further 200 innocent citizens or Amhara, in a single village of the "Beni Shangoul Goumz homeland", on the 25<sup>th</sup> of December 2020. These massacres took place only a day after the visit of Dr. Abiy Ahmed to the "homeland".

That is why, the E.C.D.U. reiterates its position that the remnant régime's main officials, including the "president" Mrs. Sahle Werq Zewdé, the "prime minister" Dr. Abiy Ahmed / በበይ : አክመድ, other régime and "homeland" officials, will be equally answerable before the law, on grounds of treason and participation in crimes against humanity, as the T.P.L.F. leadership itself.

It is with the authorisation of dictator Dr. Abiy Ahmed that, in 2017-18, thousands of Oromo Liberation Front fighters, previously trained, armed and stationed in the military camps of the outlaw Eritrean People's Liberation Front, inside Eritrea, have returned to the "Oromo homeland", fully armed and without restrictions on their movements or activities. They have since been responsible for the killing of thousands of innocent Ethiopian civilians and the displacement of millions more. The Ethiopian people know that the dictatorial rule of Dr. Abiy Ahmed has allowed these crimes to continue; and the

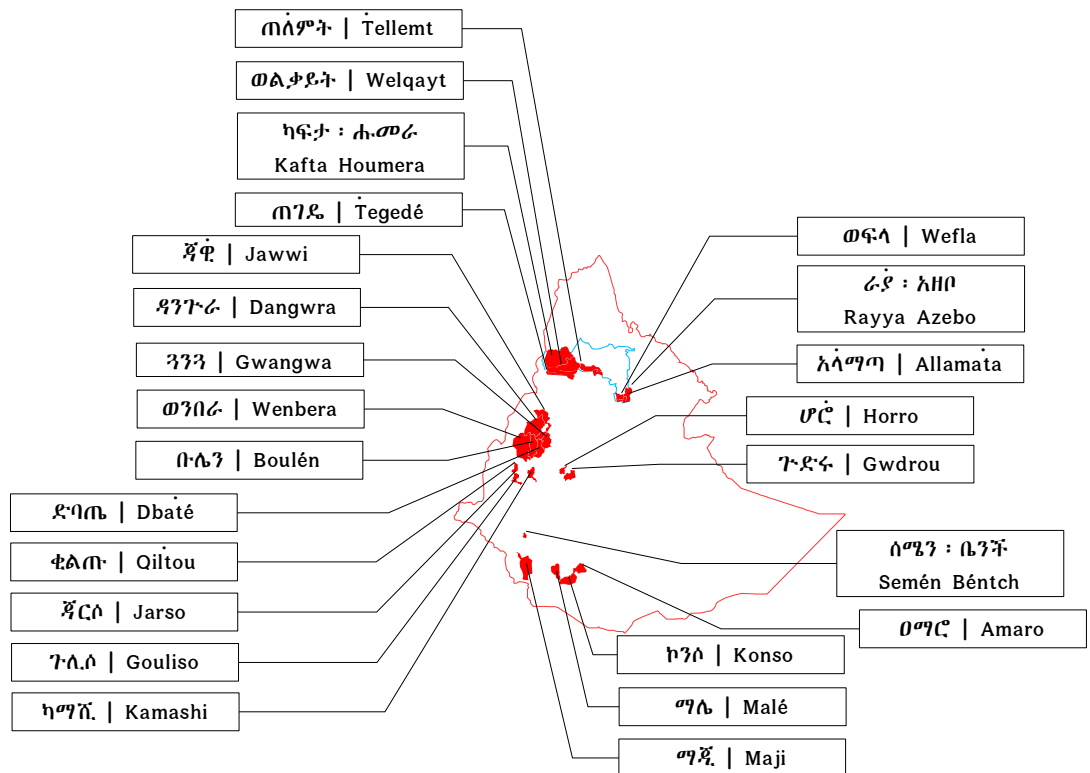




"merchants of death" have chosen to award Dr. Abiy Ahmed the "Nobel Peace Prize".

It is to be remembered also that the remnant F.D.R.E. régime has already contemptuously made clear that it will not compensate any of the tens of thousands of victims of the June 2020 massacres, looting and burning committed by bands of hooligans organized and led by the "Oromo homeland" militia as well as the O.L.F. paramilitaries.

The Ethiopians' Citizen Democratic Union (E.C.D.U.) expresses its great satisfaction with the news of the Ethiopian army's successful annihilation of the treasonous T.P.L.F. force, and their capture, on the 28<sup>th</sup> of November 2020, of the town of Meqelé / መቀሌ which the latter used as its headquarters. The members of the Ethiopian army are the product of Ethiopian Civilisation ሥልጡንአዝብና, a Civilisation of Right; despite the unrelenting nihilistic propaganda and brainwashing they have been submitted to over the past fifty years, they have, on that day, demonstrated by their victory that they have managed to uphold the eternal ideals upon which their country is founded. Fascism is



vanquished for the second time in 80 years.

At this point, we need to specially mention the watershed moment when a particular event neutralised an otherwise nefarious scheme. The Ethiopian army stationed in northern Ethiopia were on the verge of collapse following the sudden attack by the T.P.L.F. forces on the 3<sup>rd</sup> of November 2020. At this critical point in time, the green-yellow-red Ethiopian flag carrying popular forces from the provinces of Gwender, Wello, Gwedjam and Shewa, headquartered in Bahr Dar, advanced with surprising rapidity into the area to rescue the beleaguered army, and in a lightning counter-attack carried out with great determination and heroism, they decisively put out of action the renegade forces of the T.P.L.F., despite having inferior numbers and armaments; in so doing they have almost miraculously averted a potentially disastrous situation for the country, as was expected in Meqelé and Addis Abeba. This popular force has taken the lion's share in the success of what came to be known later as the "law enforcement campaign".

Even if the officials of the remnant régime were in the end forced to launch the operations they named "law enforcement campaign" because the situation would have otherwise gone out of their control, the mere fact that, having withstood pressures from outside forces, they successfully completed it, may be remembered in history as an honourable gesture to country and people.

Nevertheless, what the officials of the remnant régime call "law" is their lawless stance that does not recognise the Ethiopian people and tramples upon the people's sovereignty. As the true law enforcement campaign is one which goes as far as respecting, first, the sovereignty of the people and, second, giving way for a transitional government by making effective the nullification of the foreign inspired and unlawful F.D.R.E. "constitution", responsible for so much carnage witnessed so far in the country. The E.C.D.U. advises the remnant régime's officials to show courage by going the full distance. What history will remember as a truly great service to country and people will be such a final act at this critical political juncture.

## **2: A faltering remnant régime that has somehow undergone a shed.**

It is to be remembered that, six years ago, in July 2015, "Nobel Peace prize" winning US President Mr. Barack Obama, had visited Ethiopia, and addressed the Ethiopian puppet house of representatives where 100% of the seats are held by the ruling E.P.R.D.F. party. In his speech, president Obama extolled the burgeoning "democracy" in Ethiopia and extended the billion U.S. dollar annual aid to the dictatorial régime. The then head of intelligence of the repressive F.D.R.E. régime, today's strong man of the remnant F.D.R.E. régime, and another "Nobel Peace prize" winner, Dr. Abiy Ahmed / በቢይ ፡ አሕመድ, speaking before the same puppet Ethiopian house of



representatives on the 30<sup>th</sup> of November 2020, has made extensive "revelations" on the open secret of the tyrannical nature and workings of the régime. The **E.C.D.U.** has listened attentively to his pronouncement; the latter has merely consolidated the conclusions the **E.C.D.U.** had already arrived at, but nothing new was found in it. What the **E.C.D.U.** was hoping to hear from Dr. Abiy Ahmed was detailed information regarding the basis on which the T.P.L.F. agreed to transfer to Dr. Abiy Ahmed and his team their dictatorial powers back in 2017, and which side's breach of this secret agreement led to the present crisis. As this is not yet revealed, the **E.C.D.U.** hopefully expects Dr. Abiy Ahmed and his team, as well as the surviving members of the T.P.L.F. leadership, to give their side of the story to the investigating commission that will be set up during the transitional government period.

The one thing noteworthy in this official declaration of Dr. Abiy Ahmed is the irrefutable conclusion to be drawn from it: the systematic nature of the multidimensional damage inflicted on Ethiopia by certain foreign powers over the years, through their proxy holding régimes, in their relentless attempts to destroy her. Over the past 30 years, imperialism has established, supported and maintained in place the tyrannical and nihilistic F.D.R.E. régime in Ethiopia for a purely predatory purpose, while at the same time paying lip service to human rights and democracy. The **E.C.D.U.** seizes this occasion to ask once again the international community to recognise Ethiopia's victimization, without requiring any further evidence than this.

With the complete annihilation of the T.P.L.F., the F.D.R.E. régime has lost its support column; its collapse is only a matter of time. Today, the "Tgray homeland" is de facto dismantled; the other "homelands" will follow. The whole of Ethiopia (including Bahr Mdr / ባሕር ምድር and Denkel / ደንክል) is on the eve of a new restructuring of her administrative regions. The entire Ethiopian people and their army are rising up for this fundamental transformation. Even if it cannot be said that the one hundred year old imperialist enterprise has lost its "raison d'être", it is certainly much weaker now; as for Ethiopia, she is not yet out of the woods either.

The faltering F.D.R.E. remnant régime, like a snake that has just undergone a shed, is projecting a business as usual attitude, beyond the coming "elections", planning for the long term, and busy setting agenda for the whole Horn of Africa region. Politics should however be practised in the realm of reality and not that of wishful thinking, even less of evil thinking. It is clear that the end result will not be in the favour of the remnant régime.

With fierce determination to achieve its predatory anti-civilisation aims, imperialism seems to have decided to rehabilitate its creation, the FDRE régime, in a bid to make it



complete the mission for which it was created. This signals an imminent purge of those high ranking Ethiopian army officers who have emerged victorious in the recent operations and are irremediably opposed to the régime's nihilistic aspirations.

Whatever happens, darkness will never triumph over light; Ethiopia shall pull through these dark times in freedom, in unity and in integrity, towards a brighter tomorrow, guided and fortified by the light of her Civilisation of Right.

### 3: Decision time.

The **E.C.D.U.** wishes to strongly advise the officials of the remnant F.D.R.E. régime against following in the footsteps of the T.P.L.F. leadership, by trying to give life to the unlawful "constitution" and thus «... *return to their vomit*»; the demise and annihilation of the T.P.L.F. should serve them as a lesson.

Instead, the **E.C.D.U.** urges once again the officials of the remnant F.D.R.E. régime to follow the right way forward, and accept the legitimate request of the Ethiopian people for the respect of their sovereignty, by agreeing to call a national conference where the representatives of the Ethiopian people shall discuss the issue of the formation of a transitional government, thereby opening the new political chapter leading to the drafting and adoption phases of a new democratic Constitution for Ethiopia.

Finally, as a token of their positive overall posture vis-à-vis the above, the **E.C.D.U.**, together with its best wishes, further urges and encourages the officials of the remnant F.D.R.E. régime to quickly make effective the following:

- 1) the anti-citizen (anti-Amhara) attacks that are perpetrated in different "homelands" around the country, and until recently attributed to the now defunct T.P.L.F., are still continuing unabated, with evidence showing the involvement of highest placed officials of the remnant régime; these acts constitute crimes of national treason, and must be stopped from their sponsoring points at once; to that effect, "prime minister" Abiy Ahmed, on who's watch the massacres are repeatedly occurring, must be removed from his responsibilities, and be placed under house arrest, pending investigations;
- 2) political leaders such as Mr. 'Skindr Negga / አስክንድር ፡ ነጋ and media professionals who were wrongfully arrested following the regime-organised June 2020 massacres, must be released from prison immediately;
- 3) the divisive expression "peoples" drawn from the vocabulary of the enemy and misused with fascistic fervour by officials of the régime to designate the one Ethiopian people and sole sovereign of Ethiopia, thereby making the country ownerless, such a hostile expression must be extirpated from declarations of



- officials of the remnant regime, and the media that are under their control;
- 4) the reprobate stance and acts of enmity avowedly practised until now against Ethiopia's unique citizen language, Amharic, must be publicly condemned and revoked, so that due respect, attention and care is shown to it;
  - 5) the pentagonal star on a blue background – symbol of the now further diminished fascism, imperialism and apartheid – were previously placed on our national flag by an unlawful "promulgation"; the régime must now peaceably remove it by issuing another "promulgation" to that effect.

The Ethiopian flag constitutes for the Ethiopian people the representation of their freedom, their sovereignty, and their unity; or, in other words, the Ethiopian flag is to the Ethiopian people their symbolic representation of an independent country standing on the foundations of its own civilisation. Today, the Ethiopian people, together with their army, have once more risen in unison with their green-yellow-red national flag to fulfil their sacred duty to regain their freedom, reassert their sovereignty, and restore their democratic State of Right. In this regard, they do not need to request or obtain authorisation from anybody. Should any tyrannical force dare to oppose them, the Ethiopian people are fully entitled to fight them by all means, peaceful or otherwise; in the absence of a legitimate government, as is the case today, the Ethiopian army is duty bound to submit to the authority of the Ethiopian people ❖

## COMMUNIQUÉ DE PRESSE

[traduction française de l'original en amharique]

### Un régime résiduaire en faillite.

Londres, le 6 janvier 2021.

Traître à l'Éthiopie depuis ses commencements, le F.P.L.T. (Front Populaire de Libération du Tgray) a commis, dans la nuit du 3 novembre 2020, des massacres particulièrement barbares qui ont coûtés la vie à des civils, et des militaires stationnés dans les districts septentrionaux des provinces du Gwender / ጎንደር et du Wello / ወሎ ainsi que dans l'ensemble de la province du Tgray / ትግራይ, dans un acte ignoble, de désespoir complet, sans le moindre égard pour la sainteté de la vie humaine. Cette organisation est responsable du meurtre de plusieurs milliers de concitoyens, de la destruction de propriétés et d'infrastructures à grande échelle. Elle a porté atteinte à la sécurité du pays en attaquant des postes de l'armée éthiopienne ; de surcroît, elle a officiellement assumé son entière responsabilité pour ces actes de trahison épouvantables.

Devant des actes aussi vicieux et perfides, il n'y a pas d'expressions de regrets ou de condamnation adéquates autres que de dire que l'organisation, F.P.L.T., doit être dissoute et bannie, et que ses responsables doivent comparaître devant la justice nationale, pour trahison, crimes contre l'humanité, et crimes de guerre.

Cependant, cette question doit être examinée par les autorités judiciaires nationales, dans le cadre d'un gouvernement de transition, car derrière ces actes traîtres et ces massacres il y a le système apartheid implanté par l'étranger, ainsi que des participants



et des complices jusque là gardés secrets. À cet égard, l'**Union Citoyenne Démocratique des Éthiopiens (U.C.D.E.)** rendra publique sa position le moment venu.

Le F.P.L.T., cette organisation hors-la-loi, n'a reçu aucun mandat des habitants respectés et patriotes de la province du Tgray ; les crimes commis contre le pays sont ceux du F.P.L.T. et ceux des forces impérialistes qui l'ont crée, financé, organisé, et téléguidé durant les cinquante dernières années. Les habitants de la province du Tgray savent qu'ils sont innocents, l'ensemble du peuple éthiopien sait que les habitants du Tgray sont innocents, le reste du monde aussi doit savoir qu'ils sont innocents. Comme preuve de leur fidélité à l'égard de leur pays, les habitants du Tgray ont montré leur entière coopération dans le cadre de la "campagne de mise en vigueur de la loi", en respectant scrupuleusement les directives de l'armée éthiopienne dans tous les théâtres d'opération, en plus de leur rejet de l'appel du F.P.L.T.. En cas de nécessité, les habitants n'ont pas hésité de se battre aux côtés de l'armée éthiopienne contre cette force hors-la-loi qui les a opprimés pendant si longtemps.

L'**Union Citoyenne Démocratique des Éthiopiens (U.C.D.E.)** exprime sa plus profonde tristesse devant le meurtre de civils éthiopiens innocents, ainsi que le sacrifice des braves qui ont confronté et vaincu le mal du fascisme ; elle prie aussi pour la rédemption de leurs âmes.

L'**U.C.D.E.** adresse ses plus sincères condoléances aux familles endeuillées ainsi qu'au peuple éthiopien tout entier, et prie Dieu de leur donner la force. L'**U.C.D.E.** est confiante que, dès la restauration de son État démocratique, l'Éthiopie procédera au dédommagement des victimes et de leurs familles.

En attendant, l'**U.C.D.E.** lance, avec ses meilleurs vœux, son appel patriotique :

- 1) aux habitants de la province du Tgray, qui viennent tout juste d'être délivrés de la tyrannie du F.P.L.T. : *«nos plus sincères félicitations en ce jour de votre libération ; il revient maintenant à vous de livrer aux forces de l'ordre les quelques criminels qui se cachent encore en votre sein et qui s'affairent à vous livrer à un nouveau cycle de souffrances» ;*
- 2) aux habitants des districts des provinces du Gwender et du Wello illégalement transférés vers le "homeland du Tgray" : *«à vous aussi, nos plus sincères félicitations en ce jour de votre libération ; jusqu'à ce que le système "apartheid des homelands" soit démantelé, et l'Éthiopie ait adopté démocratiquement une nouvelle structure administrative, gardez fermement ce qui vous reviens de droit, et pour lequel un lourd sacrifice a déjà été fait» ;*
- 3) au Peuple Libre d'Éthiopie en entier : *«nos plus sincères félicitations en ce jour de*



*victoire ; même si le caractère fratricide du combat est raison de le regretter, le perdant dans cette affaire est l'esprit maléfique du nihilisme, importé du monde occidental, qui a dressé le peuple éthiopien contre lui-même ; sa défaite aujourd'hui annonce un lendemain meilleur pour l'Éthiopie, encore une fois nos félicitations. En attendant que le système d'apartheid soit banni une fois pour toute de tout le territoire éthiopien, sache ne pas être dupé par les promesses "d'élections" et autres illusions des charlatans qui prétendent ainsi "préserver" une "constitution" illégitime. Au contraire, soulève toi à l'unisson pour reprendre en main ton pays l'Éthiopie, tout en garantissant son unité nationale et son intégrité territoriale, afin d'adopter ta nouvelle Constitution, et d'établir ton nouvel État de Droit démocratique».*

### **1: Du sang sur les mains de l'impérialisme.**

L'Éthiopie n'a pas fini de payer les conséquences de l'application forcée sur elle du système apartheid, en la forme du régime R.F.D.E. (République Fédérale Démocratique d'Éthiopie), par les États Unis d'Amérique et certaines nations occidentales en 1991, alors même que l'Afrique du Sud venait tout juste de s'en débarrasser ; un acte perfide qui surpasse celui de "Pearl Harbor" par son infamie. C'est aussi un acte qui trahit une vengeance contre le pays qui a toujours été aux avant-postes de la lutte anti-colonialiste, anti-impérialiste et anti-apartheid. Le régime ainsi imposé a, de plus, était placé entre les mains du F.P.L.T. traître.

En conséquence, durant 29 années, l'Éthiopie a été soumise à un sabotage, une répression, une discrimination, une corruption, et une mauvaise gestion généralisée, où, chaque année, les devises étrangères durement gagnées et se montant à plusieurs milliards de dollar sont détournées vers l'étranger avec une totale impunité ; tout cela sous le silence absolu des "mean"-stream media. Celles-ci ne manquent cependant pas de clamer haut et fort les supposées "croissances à deux chiffres" de l'économie éthiopienne, sans ajouter toutefois qu'il s'agit d'une croissance nominale et non réelle ; cette croissance nominale est largement annulée par une inflation galopante à deux chiffres avec au final une économie rabougrie.

Le régime dirigé par le F.P.L.T. a méticuleusement exécuté toutes les tâches clés qui lui ont été assignées, pour conduire l'Éthiopie à sa liquidation ultime en tant qu'État ; entre autres :

- 1) en acceptant d'effectuer un référendum illégal pour la sécession de la province de l'Érythrée, cédant illicitement une part significative de sa population, de ses territoires du Bahr Mdr / ባሕር ምድር et du Denkel / ደንክል, ainsi que la totalité de ses côtes sur la Mer Rouge ;





- 2) en mettant en péril l'unité nationale et l'intégrité territoriale de l'Éthiopie par une segmentation de sa population et de son territoire sur la base des origines ethniques ;
- 3) en adressant le peuple éthiopien, au pluriel comme "les peuples", conformément à la "constitution" d'inspiration étrangère, afin de semer la division et de priver l'Éthiopie de son peuple souverain légitime ;
- 4) en essayant d'amoindrir la langue citoyenne, l'amharique, en faveur de l'anglais ;
- 5) en essayant de substituer à l'idée de la citoyenneté celle de l'ethnicité, ainsi qu'en fomentant des conflits inter-ethniques qui se sont soldés par des massacres, des déplacements en masse, et de l'exil au quotidien ;
- 6) en persécutant, en torturant et en tuant sans merci tous ceux qui s'opposent à lui ;
- 7) en détournant les ressources du pays ainsi que les deniers publiques ;
- 8) par d'autres actions tout aussi déplorables.

Néanmoins, le F.P.L.T. a échoué ; il est à la place lui-même liquidé.

Trois années avant sa propre liquidation, assailli de partout par les agitations populaires dans le pays et craignant pour sa propre existence, le F.P.L.T. a cherché une issue, afin de pouvoir achever sa tâche de destruction, depuis son antre du "Tgray homeland". Ce faisant, il a passé les pouvoirs dictatoriaux à ses partenaires au sein du régime résiduaire R.F.D.E. ; sans toutefois montrer un quelconque remords pour tous les crimes qu'il a commis jusqu'à présent, autre que de dire qu'il est lui-même «*pourri*». À l'instar de ce que le Livre Saint nous dit : «*Le chien est retourné à ce qu'il avait vomi lui-même, ...*» (2Pie 2:22), le F.P.L.T. a quitté Addis Abeba pour se barricader dans ses abris au Tgray, d'où il a montré au monde entier sa vraie nature perfide, fasciste, nihiliste et viciée, en commettant les mêmes crimes atroces dans tout le pays. Il est pratiquement certifié que pour accomplir ces crimes, le F.P.L.T. a reçu l'accord complice, voire bénéficié du soutien logistique ou de la participation de certains de ses partenaires les plus importants restés aux commandes à Addis Abeba, et avec lesquels il partage la politique de "yougoslavisant" de l'Éthiopie, en cours, notamment par le biais du "nettoyage ethnique".

Il ne fait aucun doute que les tueries commises par le F.P.L.T. dans les districts du Welqayt / ወልቃይት, Tègedé / ጠገዴ, Tèlemt / ጠለምት, et Kafta Humera / ካፍታ : ሱመራ, particulièrement autour de la ville de May Kadra / ማይ : ካድራ, depuis le 3 novembre 2020 jusqu'à sa fuite, où plus de 1'500 civils ont perdu la vie, sont toutes le résultat d'un mécanisme de pensée fasciste décidé à venger la défaite du fascisme en 1941. C'est



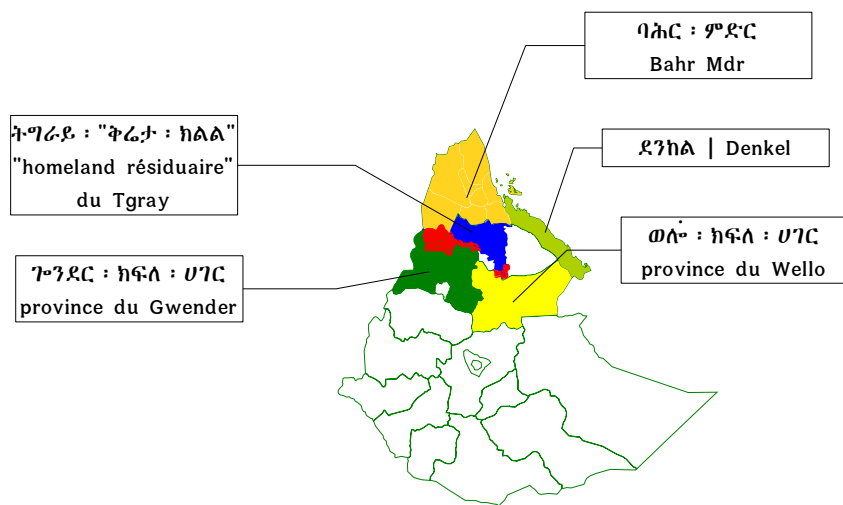
aussi un massacre semblable à celui commis dans l'enclave yougoslave de Srebrenica, visant à enclencher le processus de désintégration de l'Éthiopie.

Les raisons pour lesquelles les districts du Welqayt, Tēgedé, Tēlemt, et Kafta Humera [voir carte 1] ont été illégalement transférés de la juridiction de la province du Gwender vers celle du "Tgray homeland", dès 1991, sont :

- premièrement, pour se venger contre ses habitants, qui durant l'invasion fasciste italienne (1935-1941), ont accomplis des faits d'armes extraordinairement héroïques, sous le commandement de chefs de la résistance comme le Bitweded Adane Mekwen-n / ቤት-ወደድ ፡ አዳነ ፡ መከንን, et qui de ce fait ont valu à ces districts le surnom de "cimetières de fascistes" ;
- deuxièmement, pour doter le "homeland" du Tgray que l'impérialisme a marqué comme voué à "l'indépendance", d'un corridor vers le Soudan ;
- troisièmement, pour doter la "république-en-devenir-homeland" du Tgray, de vastes étendues de terres agricoles fertiles, en plus des districts du Rayya (ራዩ) et de l'Allamata (አላማጣ), eux aussi illégalement transférés de la juridiction de la province du Wello en 1991, garantissant par ce biais plus que l'autosuffisance alimentaire, un véritable "lebensraum" au Tgray.

Les massacres de la mi-février 2013 qui ont faits des milliers de morts parmi les civils innocents, visant à "nettoyer" les citoyens ou Amhara "non-natifs de l'ethnie locale" du :

- "Oromo / አሮሞ homeland" (au Wellegga / ወለጋ, les districts du Gouliso / ጉሊሶ, Qiltou / ቂልጡ, Djarso / ጃርሶ, Horro / ሆሮ, Gwdrou / ጉድሩ ...),
- "Beni Shangoul Goumz / በኒ : ሻንጉል : ጉምዝ homeland" (au Metekkel / መተክል, dans les districts du Mandoura / ማንዱራ, Boulén / ቡሌን, Dbaté / ደባጤ, Kamashi / ካማሽ., ...),
- "Deboub / ደቡብ homeland" (dans les districts du Semén Béntch / ሰሜን : ቤንች, Madji / ማጂ, Konso / ኮንሶ, Amaro / ፀማሮ, Malé / ማሌ, ...),

étaient à peine mentionnés dans les communiqués de presse habituels du régime résiduaire R.F.D.E. dirigé par le parti F.P.R.D.E. -Parti de la Prospérité, jusqu'au moment



où, selon le porte parole du ministère des affaires étrangères, «*la ligne rouge a été finalement franchie*» lorsque des divisions de l'armée stationnées dans le "Tgray homeland" ont été attaquées par les forces du F.P.L.T ; ce n'est qu'à ce moment tardif que la "campagne de mise en vigueur de la loi" a été lancée. Plusieurs éléments sont venus confirmer que jusqu'à l'attaque du 3 novembre 2020 contre l'armée, le régime résiduaire R.F.D.E. s'était contenté d'accuser les agitateurs du F.P.L.T. d'être à l'origine des massacres de "nettoyage ethnique" – qui en réalité sont des massacres anti-citoyen/ne ou anti-Amhara – perpétrés un peu partout dans le pays, sans pour autant prendre les mesures d'ordre public, en raison de son soutien tacite pour le résultat final : la consolidation de "homelands républiques-en-devenir ethniquement nettoyés". Au moment où nous nous apprêtons de compléter le présent communiqué de presse, nous avons appris avec beaucoup de tristesse le massacre de plus de 200 citoyens éthiopiens ou Amhara dans un seul village du "Beni Shangoul Goumz homeland". Ces massacres se sont déroulés au lendemain de la visite du Dr. Abiy Ahmed dans le "homeland".

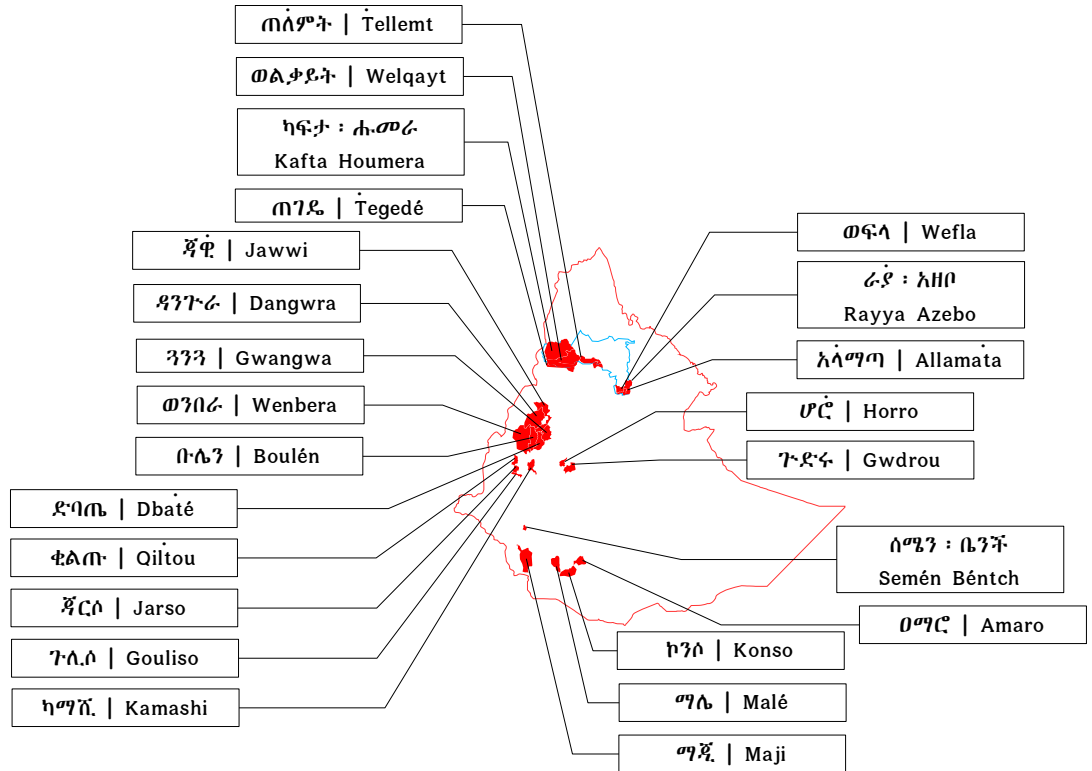
C'est pourquoi l'U.C.D.E. réitère sa position selon laquelle les principaux responsables du régime résiduaire, y compris la "présidente" Mme. Sahle Werq Zewdé / ማህላ : ወርቅ ፡ ዘውዴ, le "premier ministre" Dr. Abiy Ahmed / ዐቢይ ፡ አሕመድ, les autres hauts responsables du régime, ainsi que les principaux responsables des "homelands", auront des comptes à rendre devant la justice au même titre que la direction du F.P.L.T., pour trahison et participation à des crimes contre l'humanité.

C'est avec l'autorisation du dictateur Dr. Abiy Ahmed, en 2017-18, que des milliers de combattants du Front de Libération Oromo (F.L.O.), entraînés, armés et stationnés dans les camps militaires du Front Populaire de Libération de l'Érythrée (F.P.L.E.), à l'intérieur de l'Érythrée, ont pu retourner au "Oromo homeland", entièrement armés, et sans aucune restriction quant à leurs mouvements et leurs activités. Ils sont, depuis, responsables du massacre de milliers de civils innocents, ainsi que du déplacement de plusieurs millions d'autres. Le peuple éthiopien sait que la dictature du Dr. Abiy Ahmed a rendu possible ces crimes ; et les "marchands de la mort" ont choisi de lui attribuer le "Prix Nobel de la Paix".

Il faut se rappeler aussi que le régime résiduaire R.F.D.E. a d'ores et déjà fait savoir qu'il ne dédommagerait aucune des dizaines de milliers de victimes des massacres, des pillages et des incendies criminels que des bandes de loubards appuyés et encadrés par les milices du "Oromo homeland" et les paramilitaires du F.L.O., ont perpétrés, au mois de juin 2020.

L'Union Citoyenne Démocratique des Éthiopiens (U.C.D.E.) exprime sa grande satisfaction à l'annonce que l'armée éthiopienne a complété l'anéantissement des forces traîtres du F.P.L.T. suite à ses opérations dans le Tgray, ainsi que le contrôle total de la ville de Meqelé / መቀሌ qui servait de quartier général aux forces du F.P.L.T.. Les membres de l'armée éthiopienne sont le produit de la Civilisation éthiopienne ሥልጡንሕዝብና, une Civilisation de Droit ; malgré les incessantes propagandes nihilistes et les lavages de cerveaux qu'ils ont subis durant les dernières cinquante années, ils ont démontré par leur victoire qu'ils sont parvenus à préserver jusqu'à ce jour les idéaux sur lesquels leur pays est fondé. Ainsi le fascisme a été vaincu pour la seconde fois en 80 ans.

Ici, nous devons mettre en exergue le moment décisif où un événement particulier a neutralisé un traquenard autrement néfaste. Les unités de l'armée éthiopienne stationnées dans le nord du pays, ont failli être anéanties suite aux attaques soudaines des forces du F.P.L.T., le 3 novembre 2020. À ce moment critique, les forces populaires des



provinces du Gwender, du Wello, du Gwedjam et du Shewa, dont le quartier général est à Bahr Dar, portant le drapeau éthiopien aux couleurs vert-jaune-rouge, se sont lancées dans la région avec rapidité et ont secouru l'armée aux abois, avant de mettre hors d'état de nuire les forces rebelles du F.P.L.T. avec détermination et héroïsme, tout cela malgré leur nombre et leur armement inférieurs ; ce faisant, ils ont réussi à déjouer une situation potentiellement désastreuse pour le pays, vue de Meqelé et d'Addis Abeba. Cette force populaire s'est taillée la part du lion dans le succès de ce qui est devenu, après, la "campagne de mise en vigueur de la loi".

Même si les officiels du régime résiduaire ont été forcés de lancer l'opération qu'ils ont appelée "campagne de mise en vigueur de la loi" pour éviter que la situation n'échappe à leur contrôle, il se peut que l'histoire retiendrait en leur faveur l'exécution réussie des opérations, cela malgré les pressions extérieures, comme une action honorable à l'endroit du pays et du peuple.

Néanmoins, ce que les officiels du régime résiduaire appellent "loi" c'est leur position hors-la-loi qui ne reconnaît pas le peuple éthiopien, et qui bafoue sa souveraineté. La vraie campagne de mise en vigueur de la loi est celle qui va aussi loin que le respect de la souveraineté du peuple, et ensuite l'annulation pure et simple de la "constitution" d'inspiration étrangère et illégitime du régime R.F.D.E., responsable de tant de carnages dans le pays. L'U.C.D.E. conseille aux officiels du régime résiduaire de faire preuve d'avantage de courage pour aller jusqu'au bout. Ce que l'histoire retiendra comme un grand service pour la patrie et le peuple, ce sera une telle action finale en cette période politique critique.

## **2: Un régime résiduaire défailant qui a tout de même accompli sa mue.**

On se souviens que, il y a à peine six ans, en juillet 2015, le président des États Unis d'Amérique, prix Nobel de la paix, M. Barack Obama, lors de sa visite en l'Éthiopie, avait fait un discours devant le parlement fantoche éthiopien où 100% des sièges sont occupés par le parti au pouvoir le F.P.R.D.E.. Dans son discours, le président Obama a fait l'éloge de la "démocratie éthiopienne en plein essor", avant de renouveler l'aide annuelle américaine d'un milliard de dollar au régime dictatorial. À l'époque chef des renseignements du régime R.F.D.E., aujourd'hui homme fort du régime, et autre prix Nobel de la paix, le Dr. Abiy Ahmed / በቢይ ፡ አሕመድ, s'adressant au même parlement fantoche éthiopien, le 30 novembre 2020, a fait des "révélations" — secrets de Polichinelle — quant à la nature et au fonctionnement tyrannique du régime. L'U.C.D.E. a écouté le discours attentivement : celui-ci a simplement consolidé les conclusions auxquelles l'U.C.D.E. était déjà arrivée, sans apporter une quelconque nouveauté. Ce que l'U.C.D.E. aurait souhaité entendre de sa part c'est une information détaillée concernant



la base sur laquelle le F.P.L.T. a accepté de passer les pouvoirs dictatoriaux au Dr. Abiy Ahmed et à son équipe, en 2017, et laquelle des deux parties a manqué aux termes de cet accord secret pour provoquer la présente crise. Comme ceci n'est pas encore révélé, l'**U.C.D.E.** s'attend avec espoir à ce que le Dr. Abiy Ahmed et son équipe, ainsi que les membres survivants de la direction du F.P.L.T. donnent leurs versions des événements à la commission d'investigation qui sera établie durant la période du gouvernement de transition.

Le point notable dans la déclaration officielle du Dr. Abiy Ahmed est la conclusion irréfutable que l'on peut en tirer : la nature systématique des dommages multidimensionnels infligés à l'Éthiopie par certaines puissances étrangères au cours des ans, dans leur acharnement à la détruire par le biais de régimes mandataires. Durant les 30 dernières années, l'impérialisme a établi, soutenu et maintenu en place le régime tyrannique et nihiliste de la R.F.D.E. dans un but purement prédateur, tout en prétendant défendre les droits humains et la démocratie. L'**U.C.D.E.** saisit cette occasion pour demander encore une fois à la communauté internationale de reconnaître la persécution de l'Éthiopie, sans nécessiter d'avantage de preuve.

Avec l'anéantissement complet du F.P.L.T., la colonne vertébrale du régime R.F.D.E. a été brisée ; son effondrement n'est plus qu'une question de temps. Aujourd'hui le "Tgray homeland" n'est plus ; les autres "homelands" suivront de même. Toute l'Éthiopie (y compris le Bahr Mdr / ባሕር ምድር et le Denkel / ደንክል) est à la veille d'une restructuration de ses régions administratives. Le peuple éthiopien dans sa totalité ainsi que son armée sont entrain de se soulever pour cette transformation fondamentale. Il est certes encore trop tôt pour proclamer que l'entreprise centenaire de l'impérialisme ait perdu sa raison d'être, mais elle est certainement affaiblie ; quant à l'Éthiopie, elle n'est pas non plus au bout du tunnel.

Le régime résiduaire défaillant, tel un serpent qui a accompli sa mue, veut projeter une attitude sereine comme si de rien n'était ; au-delà des prochaines élections, il paraît occupé à donner le ton dans les affaires de toute la Corne de l'Afrique. La politique doit cependant être pratiquée dans la sphère de la réalité et non dans celle des vœux pieux, et encore moins celle des vœux maléfiques. Il est clair que la fin du régime résiduaire ne sera pas des plus heureuses.

L'impérialisme semble s'acharner à réaliser ses visées prédatrices anti-civilisation en Éthiopie ; pour cela il est décidé à réhabiliter sa création, le régime R.F.D.E., afin de le faire compléter la mission pour laquelle il a été créé. Pour cette raison, nous voyons à l'horizon le déclenchement d'une nouvelle purge visant les officiers supérieurs de l'armée sortis vainqueurs des récentes opérations, et irrémédiablement opposés aux aspirations



nihilistes du régime.

Quoi qu'il advienne, les ténèbres ne triompheront pas sur la lumière ; l'Éthiopie traversera cette passe des ténèbres, guidée et raffermie par la lumière de sa Civilisation de Droit, pour émerger sur un lendemain lumineux, dans la liberté, l'unité et l'intégrité.

### **3: Le temps de la décision.**

Aux officiels du régime résiduaire R.F.D.E., l'U.C.D.E. souhaite leur indiquer avec fermeté que la mort et l'annihilation que le F.P.L.T. a récemment subites leurs servent de leçon, et, en voulant donner une seconde vie à une "constitution" illégitime, ils ne retournent eux aussi à ce qu'ils avaient "vomi".

Au contraire, l'U.C.D.E. exhorte encore une fois les officiels du régime résiduaire R.F.D.E. de s'engager dans la bonne direction en acceptant de satisfaire à la demande légitime du peuple éthiopien que sa souveraineté soit respectée, en s'engageant à appeler une conférence nationale où les représentants du peuple éthiopien délibéreraient librement sur la question de la formation d'un gouvernement de transition, ouvrant ainsi la voie vers un nouveau chapitre politique qui mènerait aux phases de préparation et d'adoption d'une nouvelle Constitution démocratique pour l'Éthiopie.

Enfin, en gage de leur disposition positive à l'égard de ce qui précède, l'U.C.D.E. incite et encourage les officiels du régime résiduaire R.F.D.E. de s'engager à rendre effectifs les points suivants dans les meilleurs délais :

- 1) ces attaques anti-citoyen/ne (anti-Amhara) dans les différents "homelands" un peu partout dans le pays, qui jusque là étaient attribuées au F.P.L.T. aujourd'hui anéanti, continuent sans relâche, avec autant de preuves démontrant l'implication des plus hauts responsables du régime résiduaire ; ces actes constituent des crimes de trahison nationale, et doivent être immédiatement stoppés à leurs points de procuration ; à cet effet, le "premier ministre" Abiy Ahmed – sous les responsabilités duquel ces massacres répétés se sont produits – doit être démis de ses fonctions, et assigné à résidence, en attendant les investigations ;
- 2) les leaders politiques, tels M. 'Skindr Negga / አስክንድር ጎጋ, et les professionnels des media qui ont été indûment emprisonnés au lendemain des massacres de juin 2020 organisés par le régime, doivent être libérés urgemment ;
- 3) l'expression "peuples", tirée tout droit du vocabulaire de l'ennemi, et usée de travers avec une ferveur fasciste par les officiels du régime en parlant du peuple éthiopien, cela dans le seul but de priver l'Éthiopie de son unique peuple souverain, cette expression source de discorde doit être extirpée des déclarations officielles, ainsi que de celles des média qui sont sous leur contrôle ;





- 4) ils doivent condamner en public et révoquer leur attitude déplorable et leurs actes ennemis à l'encontre de la langue citoyenne, l'amharique, pour lui montrer le respect, l'attention et les soins qui lui sont dus ;
- 5) l'étoile pentagonale sur fond bleu – symbole à la fois du fascisme, de l'impérialisme, et de l'apartheid, aujourd'hui d'avantage amoindris – a été placée précédemment sur notre drapeau national par une "promulgation" illégale ; le régime doit maintenant l'enlever de manière pacifique par une autre "promulgation".

Le peuple éthiopien voit son drapeau national comme la représentation de sa liberté, de sa souveraineté, et de son unité ; ou, en d'autres termes, le drapeau éthiopien est pour le peuple éthiopien la représentation symbolique d'un pays indépendant établi sur les fondements de sa propre civilisation. Désormais, le peuple éthiopien, avec son armée, et portant son drapeau aux couleurs vert, jaune, rouge, s'est à nouveau redressé à l'unisson pour accomplir ses devoirs sacrés : recouvrer sa liberté, regagner sa souveraineté, et rétablir son État de Droit démocratique. À cet égard, il n'est tenu de demander ou de recevoir l'autorisation de qui que ce soit. Au cas où une force tyrannique déciderait de s'y opposer, le peuple éthiopien est en droit de la combattre par tous les moyens, pacifiques ou non ; en l'absence d'un gouvernement légitime, caractéristique de la situation présente, il est du devoir de l'armée éthiopienne de se soumettre à l'autorité du peuple éthiopien ❖
